#### **Our Mission**

FHCi is committed to *expanding the use of and* access to homeoprophylaxis *(HP) internationally for* the prevention of infectious contagious disease. We are *dedicated to ongoing research* regarding the efficacy and effectiveness of HP and its short-term and long-term health outcomes in participating children around the world. *Through providing access to* this safe, non-toxic program, our aim is for parents and communities to become empowered by witnessing the healthy maturation of their children and their immune systems.



#### **Foundation**

In 2009, a small group of homeopaths began the process of registering children to undertake a multi-year, selfadministered HP program. This project, formally known as the Long-Term Homeoprophylaxis Study, marked the birth of FHCi and our formation as a nonprofit dedicated to research, awareness, and access to homeoprophylaxis. Our focus has always been the health and well-being of children.

All families enrolled in this foundational study were part of the long-term research study. Enrollment ended December, 2014, tracking was completed in 2018, and 2019 was spent verifying and analyzing the data. The results of this study have been made available on our website,

1,765 children have enrolled in our Childhood Infectious Disease HP Program. Research shows those who use HP have improved general health outcomes and robust immune systems!

through articles, peer-reviewed journals, and a selfpublished book. We continue to offer families and their children access to a variety of HP programs and our commitment to research continues.



## Long-term Study Results

Conclusions of our long-term study indicate that when middleclass families of unvaccinated and partially vaccinated children understand the protocol, and are supported by knowledgeable supervisors, they are able to successfully complete this HP program; and demonstrate that HP offers both unvaccinated and previously vaccinated children a low-risk immunization method that improves general health outcomes.

## History of Homeoprophylaxis

Homeoprophylaxis has been part of the practice of homeopathy for the



last 200 years. However, it was not developed as a formal public health model for infectious disease until 1985, when Dr. Isaac Golden established a program under his research model in Australia. He continued to refine his study for 15 years, following over 2,500 children for the duration of that program. The statistics of his studies are noted in our book: **The Solution ~ Homeoprophylaxis the Vaccine Alternative.**  HP has been part of the practice of homeopathy <u>for the last</u> <u>200 years.</u>

## Why HP?

Homeoprophylaxis (HP) offers a multitude of benefits including disease recognition and resolution, fulfillment of underlying susceptibility – individual and familial, and the development and growth that comes after an illness. Parents know this. 

# Corona Virus Research

In 2020 our commitment to research continued. At the onset of the COVID-19 pandemic, FHCi was poised to establish our own exploration regarding *HP application in real-time*. As HP Supervisors your interest and knowledge helped 1,169 individuals of all ages register into research! In June, our core team of nine Supervisors and six Family Members

began analysis of the data; our research was to determine the safety, effects, and efficacy of Novus-CV in humans regarding the immunological symptoms of COVID-19.

Our results suggest that Novus-CV offers a low-risk intervention that can be used in active cases to resolve Covid-like disease expression, including physical, mental and emotional components, can inhibit indications of Covid-19, and if used on a large

> The chart on the right compares dosing dates with Novus-CV to active Covid-19 cases and reported deaths in 2020. Death rates are indicated in black (on the left axis), and active cases in red (on the right axis).<sup>[i]</sup>

The first single dose was administered on February 24, 2020. The week of March 25-31 was the peak dosing period for the single dose. 201 doses were taken during that week. 198 triple doses were taken the week April 1-7. The last doses recorded were on June 24.



scale can serve as a catalyst to pandemic resolution. While we do not know the grand results of our work on the pandemic, and we have been operating from the eye of the storm, we do know that each one of us was deeply transformed in our hearts and minds through the work. *The gratitude of participants in the study was palpable* through the feedback forms. This work is much larger than any one individual can fully comprehend – what we

1,169 individuals of all ages registered into our CV research! can say is our hope is that those who come across this research will also access the shift in consciousness to another way of immune system education towards infectious disease.

Look for two articles forthcoming regarding safety and efficacy, and immunological and proving effects.

We recommended all HP Supervisors and Family Members to repeat either the 1M triple dose or take a 10M triple dose on October 16. During the week of October 29, mass annual influenza immunization program was pushed in the United States.

## **Private Membership Association**



In 2021, FHCi is focused on expanding protections for its HP Supervisors by implementing a Private Membership Association (PMA) structure. As alternative healthcare practitioners, we

are well aware of the potential for government overreach when it comes to nonpharmaceutical products. When a PMA is properly in place, what occurs inside the PMA is generally not subject to any public law, regulation, or agency rule. Instead, the PMA involves persons asserting and standing on their unalienable constitutionally secured rights to contract outside of the public domain. When members of a PMA interact with each other privately and in the private domain, they are protected from censorship and control from the government and administrative agencies. FHCi is dedicated to preserving access to HP through products, education, training, community and service. This new PMA structure will solidify this mission, as well as protect the rights of HP Supervisors and Family Members.
